## ORDER SUSPENDING LICENSE FOR NON-PAYMENT OF CIVIL PENALTY

AND NOW, this X day of July 2016, the State Board of Medicine, upon consideration of the November 24, 2015 Final Order at file number 14-49-06255 which imposed a \$500.00 civil penalty on Respondent and Respondent's failure to pay the civil penalty, hereby SUSPENDS Respondent's license, license no. RT005802, until such time as the civil penalty is paid in full.

Respondent shall immediately cease practicing and return his license, wall certificate, and wallet card, along with the civil penalty made payable to the "Commonwealth of PA" to:
