JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Medicine ("Board") and Tyler LeFebvre, as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Mr. LeFebvre's application for licensure to practice as an Athletic Trainer in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. Tyler LeFebvre, submitted an application for a license to practice as an Athletic Trainer in the Commonwealth of Virginia, which was deemed complete on June 11, 2019.
- 2. Mr. LeFebvre violated Virginia Code §§ 54.1-2915 (A) (18) and 54.1-111 (A) (1) and (4) in that, from approximately March 1, 2019 to at least March 2019, he practiced as an Athletic Trainer in the Commonwealth of Virginia without holding a valid license, as required under Virginia Code §54.1-2957.4. A.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Medicine hereby ORDERS as follows:

 Tyler LeFebvre's license to practice as an Athletic Trainer in the Commonwealth of Virginia is APPROVED.

2. Mr. LeFebvre is REPRIMANDED.
