Dear Darrell:

Please be advised that the Board of Certification, Inc. (BOC) Professional Practice and Discipline Committee (Committee) has rendered the following decision with respect to the charge that you violated Code 3.10 of the Code of Professional Responsibility (COPR) section of the BOC Standards of Professional Practice (2019).

In a Charge letter dated May 12, 2021, the BOC informed you that the Committee had determined that good cause existed to believe that you have violated Code 3.10 of the COPR section of the BOC Standards of Professional Practice because March 29, 2020, you were arrested, booked, and charged with VIDEO VOYEURISM 19 YOA OR OLDER 1st OFF, a third-degree felony. January 6, 2021, you pled Nolo Contendere to Video Voyeurism By A School Employee (810.145 2a & 8a2), a second degree felony and sentenced to incarceration of three (3) years with credit for two (2) days' time served and committed to the St. Johns County Department of Corrections. After you serve the balance of the term, you shall be placed on Sex Offender Probation for a period of five (5) years under the supervision of the Department of Corrections.

Factual Findings

1. March 28, 2020, you were arrested and charged with Third Degree Felony Video Voyeurism 19 YOA Or Older 1st Off (810.145 2) and booked into jail.
2. March 30, 2020, you were released on \$1500 bond and issued a Pre-Trial Release No Contact Order from St. John's County, Florida Circuit County Court.
3. April 17, 2020, the BOC sent you a Notice & Emergency Suspension Order electronically via Eversign.
4. April 20, 2020, the BOC attempted to call and leave a voicemail as the documents had not been viewed. The first phone number on your profile was a school phone number and the second phone number was not a working number.
5. April 21, 2020, your charge was amended to Second Degree Video Voyeurism By A School Employee (810.145 2a & 8a2).
6. June 15, 2020, the BOC resent the Notice & Emergency Suspension Order via USPS certified mail.
7. June 27, 2020, per USPS records, the letter was delivered and signed for by you. The BOC did not receive a response from you.
8. January 6, 2021, you pled No Contest to Second Degree Video Voyeurism By A School Employee (810.145 2a & 8a2) and sentenced to incarceration of three (3) years with credit for two (2) days' time served and committed to the St. Johns County Department of Corrections. After you serve the balance of the term, you shall be placed on Sex Offender Probation for a period of five (5) years under the supervision of the Department of Corrections.

9. February 7, 2021, as a resolution, the BOC sent you a Consent Agreement for suspension of your certification via USPS certified mail. The Consent Agreement stated you may petition for reinstatement after suspension no sooner than completion of three (3) years of incarceration.
10. February 16, 2021, the Consent Agreement was signed for as received by Ashley Edwards. The BOC did not receive a response from you.
11. April 18, 2021, the BOC mailed you a Charge letter via USPS certified mail.
12. April 27, 2021, USPS returned the letter to the BOC stating Inmate Not Here.
13. May 12, 2021, the BOC mailed you, via USPS certified mail, the Charge letter to Central Florida Department of Corrections where you are currently being held.
14. May 18, 2021, per USPS tracking, the letter was delivered. The BOC did not receive a response from you.

Conclusions

Based on the lack of response to BOC notifications, the Committee determined that the facts above are valid and that such actions violate Code 3.10 of the COPR section of the BOC Standards of Professional Practice (2019):

Code 3.10: The BOC certified athletic trainer takes no action that leads, or may; lead, to the conviction, plea of guilty or plea of nolo contendere (no contest) to any felony or to a misdemeanor related to public health, patient care, athletics or education; this includes, but is not limited to: rape; sexual abuse or misconduct; actual or threatened use of violence; the prohibited sale or distribution of controlled substances, or the possession with intent to distribute controlled substances; or improper influence of the outcome or score of an athletic contest or event.

As a result, the Committee has issued the following sanctions regarding your certification:

Your certification status is considered Suspended. Suspension of a BOC certification is considered public information and may be published or otherwise disclosed by the BOC. Further, while your certification is Suspended, you are not authorized to do the following:

1. Represent yourself to the public as a practicing Certified Athletic Trainer or use the certification marks "ATC" following your name; or
2. Serve as an item writer for the BOC certification exam; or
3. Serve as a supervisor of students who are satisfying the athletic training requirements for certification eligibility.

You may petition for reinstatement in accordance with Section 12 of the BOC Discipline Procedures. Such petition may be filed upon no sooner than completion of three (3) years of incarceration. Contact the BOC office for instructions how to petition for reinstatement, fees, and procedures.

Darrell, this matter will remain a part of your BOC certification file and may be used for the purpose of determining sanctions in any future matters that come before the BOC Professional Practice and Discipline Committee or other Disciplinary Panels. You have the right to appeal a decision made by the Committee. An appeal must be received by the BOC within thirty (30) days of receipt of this decision. The appeal must be written and addressed to the BOC Chief Executive Officer. For details regarding the appeal process, please see the enclosed procedures.
