Hello Nathan:

Please be advised that the Board of Certification, Inc. (BOC) Professional Practice and Discipline Committee (Committee) has rendered the following decision with respect to the charge that you violated Codes 2.2 and 3.8 of the Code of Professional Responsibility (COPR) section of the BOC Standards of Professional Practice.

In a Charge letter dated November 6, 2023, the BOC informed you that the Committee had determined that good cause existed to believe that you have violated Codes 2.2 and 3.8 of the COPR section of the BOC Standards of Professional Practice based on the fact that your 2020-2021 audit was to be completed by August 10, 2023. Per Eversign records, on November 16, 2023, you viewed the Charge letter but the BOC did not receive a response. To date, you still have not yet complied with the audit.

Factual Findings

- 1. On January 26, 2020, you submitted your 2020-2021 CEUs and attested to the following relevant statements:
 - -The information contained in this report is a true and accurate statement of my continuing education activities.
 - -I am submitting no less than 50 CEUs required for the current reporting period including 10 CEUs in Category EBP on this form.
 - -I am in possession of and prepared to present all original documentation confirming participation in reported activities. I am aware I must keep these records for at least 2 years after the reporting period has ended.
 - -I am aware that I am required to maintain ongoing certification in Emergency Cardiac Care (ECC) throughout the reporting period and I must keep these records for at least 2 years after the reporting period has ended.
 - -I am aware that the BOC reserves the right to audit me at any time and that failure to comply with BOC audit policies may result in the suspension of my BOC certification.
 - -I am aware that falsification of this report may result in the suspension of my BOC certification.
- On December 13, 2022 and January 10, 2023, the BOC emailed you audit reminders.
- 3. On December 17, 2022, the BOC mailed you an audit notice for the 2020-2021 CEU reporting period.

- 4. On January 17, 2023, you emailed BOC that you had current Professional Rescuer ECC, and that you did not understand why your card was not acceptable. You also stated that you were not practicing clinically.
- 5. On January 19, 2023, the BOC responded that the ECC card submitted was for Adult and Pediatric First Aid/CPR/AED, not Professional Rescuer and directed you to the BOC requirements for ECC.
- 6. On January 23, 2023, you replied to the BOC stating you would obtain the correct ECC and asked for an audit extension.
- 7. On January 26, 2023, the BOC emailed you stating the audit had been submitted and would be reviewed.
- 8. On March 30, 2023, the BOC evaluated your audit submission and returned it to you requesting further documentation.
- 9. On April 6, 2023, the BOC emailed you stating an extension had been given to April 21, 2023, and that you needed to resubmit your audit with required documentation.
- 10. On May 5, 2023 you emailed a screenshot of a scheduled ECC course for May 22, 2023.
- 11. On May 8, 2023, BOC responded to email that audit had been extended to May 26, 2023.
- 12. On July 27, 2023, the BOC sent Respondent an Investigation Notice electronically via Eversign as you had not complied with the CE audit.
- 13. On July 26, 2023, and August 10, 2023, you viewed the Investigation Notice.
- 14. On August 23, 2023, the BOC left a voicemail for the Respondent asking about status of ECC certification. The BOC did not receive a response.
- 15. On September 26, 2023, the BOC sent you a Consent Agreement for suspension of your certification for non-compliance with the 2020-2021 CE audit. You viewed the Consent Agreement the same day. The BOC did not receive a response.
- 16. On November 9, 2023, the BOC sent you a Charge Letter via Eversign for non-compliance with the CE audit.
- 17. On November 16, 2023, you viewed the Charge Letter via Eversign. The BOC did not receive a response.
- 18. On December 7, 2023, the BOC left you a voicemail reminder and sent you a reminder via Eversign. The BOC did not receive a response.
- 19. To date you have not complied with the CE audit.

Conclusions

Based on the lack of response to BOC notifications, the Committee determined that the facts above are valid and that such actions violate Codes 2.2 and 3.8 of the COPR section of the BOC Standards of Professional Practice:

Code 2.2: The BOC certified athletic trainer complies with the most current BOC recertification policies and requirements.

Code 3.8: The BOC certified athletic trainer ensures that any information provided to the BOC in connection with exam eligibility, certification recertification or reinstatement including but not limited to, exam applications, reinstatement applications or continuing education forms, is accurate and truthful.

As a result, the Committee has issued the following sanctions regarding your certification:

Your certification status is considered Suspended. Suspension of a BOC certification is considered public information and may be published or otherwise disclosed by the BOC. Further, while your certification is Suspended, you are not authorized to do the following:

- 1. Represent yourself to the public as a practicing Certified Athletic Trainer or use the certification mark "ATC" following your name; or
- 2. Serve as an item writer for the BOC certification exam; or
- 3. Serve as a supervisor of students who are satisfying the athletic training requirements for certification eligibility.

You may petition for reinstatement in accordance with Section 12 of the BOC Discipline Procedures. Such petition may be filed upon your ability to provide proof of compliance with the 2020-2021 CE audit or you are prepared to take the BOC Certification Exam for reinstatement. Such petitions may be subject to a background check and panel review. Contact the BOC office for reinstatement fees and procedures.

Nicholas, this matter will remain a part of your BOC certification file and may be used for the purpose of determining sanctions in any future matters that come before the BOC Professional Practice and Discipline Committee or other Disciplinary Panels. You have the right to appeal a decision made by the Committee. An appeal must be received by the BOC within thirty (30) days of receipt of this decision. The appeal must be written and addressed to the BOC Chief Executive Officer. For details regarding the appeal process, please see the enclosed procedures.
